ORDER:

The Director of Collegiate Education has forwarded the application of the Coimbatore Educational and Cultural Foundation Trust to open an unaided Arts and Science College (Co-educational) in the name of 'Sankara College of Science and Commerce' at Saravanampatty village in Coimbatore Taluk. The Director of collegiate Education has stated that the Management has provided the following:-

i) An endowment of Rs.10,00,000/- (Rupees ten lakhs) in the joint names of the Director of Collegiate Education and the Management. The amount has been credited in the Federal Bank Ltd. Coimbatore on 31.5.90.

ii) The Management has purchased 11.17 acres of land in Saravanampatty - Chinnavedampatty village.

iii) Agreement in stamp paper to abide by all the conditions prescribed by the Government.

The Director of Collegiate Education has pointed out the delay in the submission of application for opening of college and has requested the orders of the Government in the matter.

2. The Government have examined the proposal carefully. Even though the Management have satisfied the conditions, the application has been submitted belatedly after 30.9.89. However, in view of the reason that the college has been proposed to be started in a rural area the delay in submitting the application is condoned.

3. The Government permit the Coimbatore Educational and Cultural Foundation to open a co-educational Arts and Science College to be named as 'Sankara college of Science and Commerce' at Saravanampatty village in Coimbatore Taluk subject to affiliation by the Bharathiar University from the year 1990-91.

4. The permission granted in para 3 above is also subject to the following conditions:-

i) The Government will not grant any financial assistance at any time for any reason.

ii) The Management should satisfy all the conditions prescribed in G.O.Ms.No.858, Education, dated 15.7.89.

iii) Affiliation of the University should be obtained before the commencement of all the courses of study.

iv) No other courses of study except science courses and other courses allowed by the Government/University shall be conducted.

v) The teaching and non-teaching staff shall be appointed as per the yardstick and they should possess the prescribed qualifications.

vi) If the Management creates a situation causing the closure of the college for any reason, the Government will not come forward to take it over.

5) The Management is permitted to run the college in the temporary structure for one year only and ~~perit/buildings~~ /permanent should be constructed before the commencement of the academic year 1990-92.
